



Coupon and Voucher Reseller (CVR) License Agreement

Version 1.0 – April 25, 2010

By signing and returning the original/scanned-copy of this document to AnemoneSoft.com, you explicitly state that you have read and agree to all the terms in this document. You understand that only signing this document is not enough. You need to send back the signed original/scanned-copy of this document to AnemoneSoft.com and receive a confirmation code for this agreement to be valid.

Subject to your acceptance of the terms in this document upon signing and returning this document, AnemoneSoft.com grants you a non-exclusive, non-transferable, revocable license to be a Coupon and Voucher Reseller (CVR). You agree not to use this document for any other purpose, except if specifically allowed by AnemoneSoft.com. You also agree that you will keep a copy of this document and the confirmation code for your own reference/use.

AnemoneSoft.com reserves the right to change the content of this document in any way and at any time. We will notify you of any modifications to this document by posting a message that is accessible from our main website. All future revisions of this document shall also be made accessible from our main website. You agree that you will periodically check for updates to this document. You agree that you will be considered to have been given notice of any modifications once we post the message. You agree that your continued act as a CVR after such notice shall be deemed as an acceptance of the modified document. No amendment to this document shall apply to a dispute of which AnemoneSoft.com had actual notice on the date of amendment.

Your license as a CVR is conditioned upon your compliance with these terms. If you violate these terms, AnemoneSoft.com reserves the right to terminate your license at any time, without liability. This may include the invalidation of all your unused coupons and vouchers. Several warnings/notices may be issued before the actual termination of the license. A final notice will be issued on the actual termination of the license.

In case of disputes between you and your customer or between you and other CVR, you agree that you release and indemnify AnemoneSoft.com from any obligations, claims, demands, and damages of every kind and nature, both known and unknown that arise out of or in any way connected with the disputes. We reserve the right, but have no obligation, to monitor, manage, and arbitrate disputes between you and the other party.

You agree to defend, indemnify and hold harmless AnemoneSoft.com and its members from and against all claims and expenses, including attorneys' fees and costs, arising out of your act as a CVR, breach or alleged breach of any term, condition, obligation, or representation in these terms. You agree that the provisions in this paragraph will survive any termination of your CVR license.





Privacy Policy

We do not sell or rent your “Personally Identifiable Information” to any third party. We may, however, use certain information about you that is not “Personally Identifiable Information”.

AnemoneSoft.com may disclose information about you to its partners in order to provide the service related with the coupons and/or vouchers, resolve problems and correct errors in the service, and to communicate with you about the service and/or CVR-related matters. However, we do not give our partners an independent right to share this information. We may also disclose the information to a legitimate government body or department in the rare case that the laws and regulations or court order requires us to do so.

Security Policy

You need to have an account on the service that you want to be the CVR for. You understand that you will need to login to your account to resell coupons (transfer the coupons' ownership). It is recommended to login to your account using a secure e-mail or OpenID provider rather than by typing your password in the login form. You do not need to login to your account to resell vouchers. You also agree that it is your responsibility to choose a good and secure password for your account.

You agree that you will be responsible for the safety/security of all your purchased coupons and vouchers. In the case of security breaches (such as stolen account and/or vouchers), you agree to inform AnemoneSoft.com as quickly as possible so that necessary actions can be taken.

If the security breaches cause disputes between you and your customer or between you and other CVR, you agree that you release and indemnify AnemoneSoft.com from any obligations, claims, demands, and damages of every kind and nature, both known and unknown that arise out of or in any way connected with the disputes. We reserve the right, but have no obligation, to monitor, manage, and arbitrate disputes between you and the other party.

Payment Terms

All purchases of coupons and vouchers are purchased in a limited and revocable license. The coupons and vouchers may be invalidated immediately if your CVR license and/or account is terminated for any reason, if the government's laws and regulations or court order requires it, or if AnemoneSoft.com discontinues providing the services that uses the coupons and/or vouchers.

You agree that all purchases of coupons and vouchers are final. No refunds will be given, except in our sole and absolute discretion or by a preceding negotiation, before the purchases (in this case, an additional document will be provided).

If you were charged for coupons and/or vouchers you did not purchase, or if you did not receive the coupon and/or vouchers you purchased, or if you were charged an incorrect amount, you may request a refund or correction by sending an e-mail to support@AnemoneSoft.com. Please provide as accurate and complete information as possible. You agree that we may need more than one or two working days to handle the matter.





Price Regulation

The end-user price for coupons and vouchers may vary between regions and countries. You agree to buy the coupons and/or vouchers according to the price-rate of your region and/or country. Special discount can be given, depending on the amount of your purchase.

You agree not to resell the coupons and/or vouchers with price less than or more than 20% from the standard end-user price of the region and/or country. You may inquire about the standard end-user price for your region and/or country by sending an e-mail to support@AnemoneSoft.com.

In case we change the standard end-user price of coupons and/or vouchers, none of the changes shall apply to the coupons and vouchers that have been purchased before the date of change.

Requirements for Printed Vouchers

Vouchers can be physically printed to ease resell. All printed vouchers must explicitly contain:

1. The title of the service that the vouchers are meant to be used for;
2. The complete URL to access the service;
3. The “virtual currency” value of the voucher;
4. The complete code/serial number of the voucher;
5. The expiration date and time of the voucher.

However, you are allowed to add optional details, such as:

1. Your name;
2. Your contact number;
3. Images related to the service; etc.

If you plan to resell the vouchers in the form of a list/table in which end-users can choose the code/serial number they like, it is acceptable to only print the above details on the top of the page.

AnemoneSoft.com grants you a non-exclusive, non-transferable, revocable license to use any images related to the service, except the AnemoneSoft.com logo, for the voucher's printout. You agree not to use any of the images for any other purpose, except if specifically allowed by AnemoneSoft.com. You also agree not to use images from other/unrelated services. Except for images from the services, you also agree that AnemoneSoft.com will have no liability on the other additional details.

In case we change the service's URL and/or voucher's printing requirement, none of the changes shall apply to the vouchers that have been printed before the date of change. Two examples of printed vouchers are shown below (color and black-white).

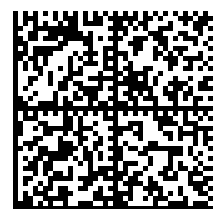
